FIRST ITEM OF BUSINESS:

Consider and take necessary action on Resolution No. 2021-24, canvassing the 2021 General Election for Mayor, Council Member District B, Council Member District D and declaring the results of the election.

An election was held in the City of Levelland, Texas on May 1, 2021, for the purpose of electing a Mayor for the City of Levelland for a three-year term ending in 2024 and Council Members in District B and D for a two-year term ending in 2023.

By approving Resolution No. 2021-24 the City Council finds that said election was duly called; that notice of the election was given in accordance with law; and that the election was conducted in accordance with laws of the State of Texas and the Charter of the City of Levelland.

To approve Resolution No 2021-24 canvassing the 2021 General Election return to declare the result.

SECOND ITEM OF BUSINESS:

Consider and take necessary action to administer the Oath of Office to Mayor, Council Member District B, Council Member District D

The City of Levelland conducted a City Officer's Election on May 1, 2021, which resulted in election of a Mayor and Council Members for seats B and D.

The Oath of Office must be administered to the newly elected candidates for the next term of two years for council members and three years for mayor.
